- ◆ Your child's name and image appearing on our school website or in the 'Bulletin' which is also uploaded to the school website for promotional purposes and to celebrate student achievement.
- ◆ Your child's image being used in promotional material (e.g. Annual School Report, Brochures, Prospectus, School Handbook etc) without any information identifying them individually or within a group. Some of these documents may also be uploaded to the school or Department of Education website.
- ◆ Your child's name and image appearing in the local newspapers which may be placed on their websites, ie the *South Coast Register*.
- ◆ Student images being placed on our school Facebook page to promote the school and our students' achievements (see below).

Parents should be aware that when information is published on public websites and social media channels, it can be discoverable online for a number of years, if not permanently. Search engines may also cache or retain copies of published information. Published information can also be linked to by third parties.
