The communications in which your child's information may be published include but are not limited to:</p> <ul style="list-style-type: none">• Public websites of the DoE including the school website, DoE intranet (staff only), blogs and wikis.• DoE publications including the school newsletter, annual school magazine and school report, promotional material published in print and electronically including on the DoE's websites.• Official DoE and school social media accounts on networks such as YouTube, Facebook and Twitter.• Parents should be aware that when information is published on public websites and social media channels it can be linked to by third parties and may be discoverable online for a number of years, if not permanently.
